EXTRACT OF MWA'S CONSTITUTION

CLAUSE 4 MEMBERSHIP

1. Membership in the Association shall be open to persons or organisations whose duties and activities respectively are such as to cause them to be interested in the science and practice of water and wastewater engineering.
2. Membership in the Association shall be of five grades: Honorary, Ordinary, Institutional and Associate and Student.

MEMBERSHIP QUALIFICATIONS

The requirements for admission shall be:

- a. Honorary Membership
A person distinguished in public life or by service to the Association
- b. Ordinary Membership
A person who possesses a tertiary qualification or holds a position of responsibility in an organisation acceptable to the Council for ordinary membership, and who is involved in the water supply or wastewater industry.
- c. Institutional Membership
A legally constituted professional institution, association, firm, company, organisation or any other similar body whose activities include or concern the water supply or wastewater industry.
- d. Associate Membership
A person who is keenly interested in the water supply or wastewater industry but not eligible for election to other classes of membership.
- e. Student Membership
A person who is a student of a higher learning institution as defined by the relevant laws and interested in the water supply or wastewater industry
